**COVERAGE:**  
One 40 lb. bag  
At the rate of 20#/1,000 will cover 2,000 SF.  
At the rate of 10#/1,000 will cover 4,000 SF.

**APPLICATION RATES:**

**For Residential & Commercial Turf:**  
Initial rate: 20 lbs. per 1,000 SF.  
Maintenance rate: 10 lbs. per 1,000 SF.

**For Golf Courses:**  
Initial rate: 20 lbs. per 1,000 SF.  
Maintenance rate: 10 lbs. per 1,000 SF.

**For Athletic & Equine Fields:**  
Spread 20-40 lbs. per 1,000 SF.

**For Nurseries & Plantings:**  
Incorporate 10-20% by volume into planting mix or soil.

**For Tree Planting & Treatment:**  
Spread 5-10 lbs. per caliper around the base of the tree or incorporate it into planting mix or soil.

**For New Sod:**  
Spread 20 lbs. per 1,000 SF before laying sod.

**For Spreader Settings:**  
Apply Essential-G with the spreader settings below.  
Lely - 4 Spyker - 4 Earthway - 14.5 PermaGreen - 14  
You may need to adjust the setting depending on walking speed, spreader condition and product.
