New Sod	Spray the ground with 2-7 ounces per 1,000 SF before laying sod	Apply prior to installation
Lawn Care (Cool & Warm Season Grasses)	Spray 2-7 ounces per 1,000 SF	Apply every 4-6 weeks during the growing season
Plants, Flowers, and Shrubs	Drench - Dilute 1 ounce with 50-100 ounces of water. Foliar - 1 ounce with 100 ounces of water.	Apply monthly
Trees	1-4 ounces per caliper inch.	Apply at installations and 1-4 times per year
Hemp & Cannabis	Drench - Dilute 1 gallon with 50-100 gallons of water. Foliar - Dilute 1 gallon with 100 gallons of water to cover leaves.	Apply as needed or consult your Mirimichi Green representative
